# What is this product?

#### Type:

This product is a UCITS Fund. The Fund is a sub-fund of Harrington Cooper UCITS Funds ICAV, an open-ended umbrella Irish collective asset-management vehicle with segregated liability between its subfunds formed in Ireland under the Irish Collective Asset-management Vehicles Act 2015 and was registered on 12 October 2018. The Fund's assets are held through its Depository, which is Northern Trust Fiduciary Services (Ireland) Limited. ### Term:

This Fund is an open-ended UCITS and has an indefinite duration. The Fund may be terminated at any time in line with the constitutional documents of the Company. ### **Investment Objective:**

The Fund has sustainable investment as its objective and seeks to provide long-term capital appreciation through investment in a diversified and actively managed portfolio of global sustainable equities.

### **Investment Policy:**

The Fund seeks to invest in a diversified portfolio of global stocks of companies that are selected with regard for both financial and sustainability criteria applied by Boston Common Asset Management, LLC (the "Investment Manager") and which are striving to deliver a cleaner, healthier and more sustainable environment. The Fund seeks to preserve and build capital through investing in companies which provide products or services enabling solutions to environmental and/or social challenge, which are positively exposed to long-term thematic sustainability pillars. The Fund will typically be fully invested, with the exception that the buying and selling of securities may temporarily generate higher levels of cash.

The Investment Manager believes that the MSCI All Country World Index (the "Index") is the most appropriate benchmark to compare the Fund's performance because it represents a diversified portfolio of global stocks. However, the Fund is not managed to replicate the performance of the Index. Since the Fund will invest in a relatively concentrated portfolio and focus on solutions to global sustainability challenges, the Fund's performance and characteristics may differ significantly from those of the Index. The Fund is actively managed. This means that the Investment Manager applies a detailed fundamental analysis in order to selectively pick companies in a discretionary manner. The Fund may use financial derivative instruments with the aim of limiting the effect that changes in foreign exchange rates may have on the value of the Fund.

### **Fund Currency:**

The base currency of the Fund is US Dollar.

### Income:

The shares will be distributing. Dividend income will be paid out to investors on at least an annual basis.

### Subscription and Redemption:

Investors may buy and sell shares on any day on which the banks in Ireland and the New York Stock Exchange are both open. An application must be submitted to the administrator, Northern Trust International Fund Administration Services (Ireland) Limited, by 12 noon (Irish Time) on the business day immediately prior to the business day of the purchase or sale.

### Intended investor:

The Fund is suitable for retail and institutional investors seeking a medium to long term investment. Before investing, investors should satisfy themselves that their attitude to risk matches the risk profile of an investment in this Fund.

The NAV per share of the Fund will be published daily and made available on the internet at Morningstar and will be updated following each calculation of NAV.



# What are the risks and what could I get in return?

### **Risk Indicator**

# What happens if Harrington Cooper Asset Management Limited is unable to pay out?
